Head of School (HOS) report highlights and discussion

Building renovation highlights: construction will begin earlier than expected. Cost has increased: prices have gone up over the last 2 years. Josh and the project team are currently looking for places to cut costs.

Enrollment updates: The board discussed the number of students applying to Sela, including the number who rank Sela in their top 3, as well as the number of current students who have applied to other schools (which doesn't necessarily mean that they will leave). The board discussed the challenge of students wanting to move to a school for 5th grade that continues into middle school, and ways to communicate with district leadership about possibilities for avoiding this.

There was discussion of the status of development of data dashboards to be created for board review of school data.
